Part-A

The plan of action chalked out by the IQAC in the beginning of the year towards quality enhancement:

- To encourage students to take part in maximum number of sport activities and to represent the college at zonal and university level.
- To undertake programmes towards students health issues, bringing spiritual consciousness among students.

Part-B

1. Activities reflecting the goals and objectives of the institution.

The college has Arts & Commerce faculties in which the arts faculty has 1411 students and the Commerce faculty has 722 students. Out of the 2233 students in Arts faculty 769 students belong to the SC/ST category. These SC/ST students belong to the extremely weaker section of the society. It is the objective of this college to uplift this class of students academically and improve their well-being in every manner.

In the context of the above we have taken the benefit of U.G.C. XI plan and under its Merged Scheme the college also utilized the scheme named “College with Relatively Higher Proportion of SC/ST/OBC Students” Under this scheme we provided stipend to meritorious SC/ST/OBC students and they were also allowed to purchase books, stationery and other items.

Under the XI plan, merged scheme the college also utilized the scheme named “Remedial coaching for SC/ST/OBC minority students and we provided remedial teaching courses to the academically weaker students.

Under the XI plan Merged Scheme the college utilized the scheme named “Career and Counseling Cell” under which the students were given counseling for various job related sectors.

In order to improve the overall personality of our students especially the SC/ST/OBC and minority students the college has taken up the following activities which reflects its goals and objectives like:

Debate competition, Essay Writing, Quiz, Poetry Recitation, Roll Playing etc. Cleanliness’ Drive. 6 Day training was given by Department of Cooperation high lighting job careers and business opportunities in the field of cooperation.

(2) New academic programmes initiated (UG and PG).

Our college is grantable college. Since last few years the Government of Gujarat has only permitted to undertake the existing academic programmes other than the existing one as it adds up to the financial burden in the salary grant hence any addition of academic programmes is a matter of approval from Gujarat University as well as the Commissioner of Higher Education, Dept of Education Government of Gujarat.

(3) Innovations in curricular design and transaction

The Gujarat University has proposed to introduce Choice Based Credit System w.e.f. Academic year 2010-2011, at Under Graduate Level Academic year 2011-2012, at Post Graduate Level hence innovations in curricular design could not be implemented. And none of the faculty members are in the Board of Studies. The Board of studies functioning in the Gujarat University has the powers to design the syllabus and the subject pattern for a given programme. Affiliated colleges have to merely implement the syllabus. Ours is a affiliated college. So far for the academic year 2011-12, one of our faculty members Prof. K.H.Elavia has informally made suggestion modification at S.Y.B.Com for semester III and IV in the subjects of Advanced Financial Management and Organisational Behavior respectively.

The entire input data of admission under taken is entered in the college computer and in turn we get students Roll displaying their roll numbers, name, subject offered by them, the category to which they belong etc. We declare our college's internal result by entering the mark sheet data of each student class wise. Our University also puts its result on its website and students are able to download the same on the basis of their university seat number. The college uses internet to download enrolment form and exam form from the University website. The students provide their personal details in these given forms and the duly filled in forms are subsequently sent online back to Gujarat University. The staff salary rolls are received online and other deduction are also sent online to the Account office, CHE, Gandhinagar.

As per the norms of Gujarat University it is mandatory for all the students in First year BA/BCOM to undergo medical check-up by government authorized medical practitioner. The doctors individually check the students and advice medical treatment to the students who need such medical treatment.

Female medical practitioner addresses the problems of girl students and in cases where any advice and treatment is necessary the same is given free of charge.

The Management of our college is also associated with Dahod Urban Bank Hospital which is always ready to take care of any health problem faced by students or the staff of this college on minimum cost basis. This hospital is also supported by Blood bank which is equipped to meet any kind of emergency arising in our college.

(33) Performance in sports activities.

The college does not have (Director of Physical Education) since the retirement of our ex D.P.Ed. No new permanent appointment of D.P.Ed. has been made by the office of Commissioner of Higher Education, Government of Gujarat.

In spite of this, the designated faculties of our college are taking up the additional charge and managing the Physical Education Department in the time available to them.

The college has taken up the sport activities like table tennis, chess, carom, badminton, cricket, volley ball, Kho-kho and also held athletic meet comprising of 100 meters 200 meters, 400 meters, 800 meters and 1500 meters race and other athletic events like long jump, high jump, discuss throw, javelin throw, shot put and 100×4 and 400×4 relay race of boys and girls.

The college held University level sports exam in the following events.

- To inculcate the value of giving service to the society our NSS wing has undertaken few programmes like forming Red Ribbon club which in turn educates people in distant rural area about the issues of HIV Aids. NSS wing has also formed a youth club in Association with SAHAJ which is an NGO empowering woman in rural areas.

CWDC wing of our college has undertaken the following extension activities for the women welfare.

- The coordinator of the CWDC and the college girl students formed separate team, visit the rural areas and try to help the women folk in various ways like making them understand the importance of pure drinking water, eating nutritional food, following healthy family planning practices, explaining to them the importance of basic health hygienic and education.

Most of our faculties use PPT to teach more effectively.

The CHE office has started BISAG education programme under which circular based lectures are telecast and the students are given the benefit of the expert lecturer in their respective subjects.

The governing body of the college motivates the institution to utilize the most appropriate UGC scheme which in turn can benefit the infrastructure and learning resources of this college.

The college encourages faculty members to present minor /major research projects and also to undertake PhD programmer.

The entire teaching and non – teaching staff is ever willing to solve any problem of any student. The entire effort is to redress any grievance of any student immediately and to see that they progress in the best possible manner.
